COVID-19 Procedures for Camp Shamineau

Social Distancing among Campers and Staff

All activities have been designed to allow for the possibility of social distancing between campers. As such, campers will be given the option of social distancing.

Meal Service

Meals are served by staff (wearing masks and gloves). Hand sanitizer is available at the beginning of these lines. Tables have been set six feet apart from one another and, depending on the number of campers present, meal-times will be staggered.

Chapel

Chapel services are held indoors. Chairs will either be set up six feet apart from one another (in compliance with the regulations for houses of worship) or will be placed at four to a table, with tables six feet apart from one another (in compliance with regulations for restaurants) if chapel is also being used to serve a meal or snack.

Musical worship during chapel will not be discouraged.

Cleaning Procedures

In all of our cleaning processes, the products we use are approved for use in the prevention of the spread of COVID-19.

Activities

Special cleaning procedures have been written for all activities offered at Camp Shamineau. Air rifles, BB guns, shotguns, bows, arrows, laser tag taggers, are sanitized between uses. Recreation equipment (basketballs, dodgeballs, Frisbees, etc.) are sanitized before and after use.

Face Coverings

Staff who come into close contact with campers (servers in the kitchen, individuals helping campers get into harnesses at the ropes course, etc.) wear masks while working with campers in outdoor settings. In indoor settings, staff, campers, and guests will be required to wear face coverings, with the exception of those exempted in Executive Order 20-81. Individuals with a medical condition, mental health condition, or disability that makes it unreasonable for the individual to maintain a face covering and individuals 5 years old or younger will not be required to wear a face covering while indoors. It will be permissible for other campers and guests to temporarily remove their face covering while indoors in several circumstances. These circumstances include while on stage, eating, sleeping or falling asleep, exercising in such a way as to make it difficult to wear a mask, or showering.

A permissible face covering covers the nose and mouth completely and may be a disposable face mask, a cloth face mask, a scarf, a bandanna, or another suitable alternative. We ask that all campers and guests come with at least one face covering.

Arrival Procedures

All individuals within a vehicle will have their temperature checked upon arrival. If anyone in the vehicle has a temperature of 100.4 degrees or greater, no one in the vehicle will be allowed to remain at camp.

Disclaimer

Insofar as we have these policies in place, we cannot guarantee the risk of COVID-19 at Camp Shamineau will be fully eliminated. Instead, these policies are in place to mitigate the spread of COVID-19 as much as possible.
